General Terms & Conditions

1. To reserve/book your stalls, the Exhibitor can visit website: www.pakplasma-expo.com.pk and follow the simple instructions on the website to book stalls. Otherwise contact sales staff and send email at sales1@pakplasma-expo.com.pk for more guidance.

The organizer will determine the final location of stands, taking into consideration the effective use of halls, the branch grouping and as far as possible, the exhibitors' wishes. The organizer will send the exhibitors a floor plan and stall number showing the location and dimensions of the stand as confirmation of participation.

The organizer is responsible for general lighting. The exhibitor will order electricity as well as the necessary installation work for his stand to the organizer or stall fabricator. Electrical installations will be performed by an electrician contractor directed by the organizer. While backup generators will be available, the organizer is not responsible for any damage caused by a power outage. The exhibitor is responsible for electrical equipment brought by him to the stand as the occupant.

Stands must be properly manned and exhibits displayed during all the time the exhibition is open to visitors. No exhibits may be removed before the end of the exhibition without the written permission of the Organizer, which will only be given in exceptional circumstances. All exhibits and stand fitting materials must be removed from the Exhibition Building within - and Exhibitor shall not enter, store or carry out any work at the exhibition building prior to - the period stipulated by the Organizer. The Exhibitor will compensate the Organizer for any expenses incurred through failing to comply with this condition. The Exhibitor shall hold the organizer safe and harmless from all loss or damage suffered by or arising from out of any act or default of any servant, agent, employee or subcontractor of the exhibitor. Deadlines for dismantling must be strictly adhere to.

The Organizer reserves the right to change location of Stalls & Raw Spaces within the specified hall or to any other halls for effective use of space and to make the exhibition better. If any alter happens, the charges of Stalls and Raw Spaces will be applicable of new location. If the new location price will be more than the Exhibitor already paid then Exhibitor is bound to pay the difference amount before the Exhibition and if the new location price will be less than the Exhibitors already paid, the excess amount will be refunded by the Organizer after the exhibition.

No alteration, addition, amendment or waiver to or of these terms and conditions shall operate to release any Exhibitor from it's contract.

7. Full payment must be made within 72 hours of the invoice.

8. Installment plan is not applicable. All necessary bank charges must be paid.
