ANNUAL ELECTION SCHEDULE OF PAKISTAN PLASTIC MANUFACTURERS ASSOCIATION

Members are hereby notified that the Biennial Elections of the Pakistan Plastic Manufacturers Association (PPMA), in accordance with the Trade Organizations Act, 2013, the Trade Organizations Rules, 2013 and the Memorandum & Articles of Association of PPMA, shall be held for the term commencing from 1 October 2026 to 30 September 2028 at the registered office of the Association situated at Suite No. 8, 2nd Floor, B-9/B-2, Estate Avenue, Metro Chowrangi, S.I.T.E., Karachi.

The Elections for the term 2026–2028 shall be held as per the following schedule, which was approved by the Executive Committee at its meeting held on 16 June 2026.

The Election Commission shall perform its functions in accordance with the Trade Organizations Act, 2013, the Trade Organizations Rules, 2013, and the Memorandum & Articles of Association of the Pakistan Plastic Manufacturers Association (PPMA) for the conduct of the elections.

ANNOUNCEMENT OF ELECTION SCHEDULE AND INVITATION OF NOMINATIONS FOR THE EXECUTIVE COMMITTEE

The approved Election Schedule for 2026–2028 is enclosed herewith. Accordingly, elections shall be held to elect Twelve (12) Members of the Executive Committee for the term 2026–2028, comprising Eight (8) Corporate Members and Four (4) Associate Members, in accordance with the Trade Organizations Act, 2013, the Trade Organizations Rules, 2013, and the Memorandum & Articles of Association of the Pakistan Plastic Manufacturers Association (PPMA).

ELIGIBILITY TO VOTE & ELECTORAL COLLEGE

As per Rule 21(5)(c) of the Trade Organizations Rules, 2013, the Electoral College for each class of members of the Executive Committee shall comprise the members of the General Body from the respective class.

As per Rule 15 of the Trade Organizations Rules, 2013 and the Memorandum & Articles of Association of the Pakistan Plastic Manufacturers Association (PPMA), the eligibility of a member to vote in the elections shall be subject to the following conditions:

a) The member has completed at least two (2) years of valid membership of PPMA as on the date of announcement of the Election Schedule by the Executive Committee:

Provided that old members shall be eligible to vote on completion of one (1) year of their re-enrolment and payment of all outstanding dues; and

b) The member has fulfilled the conditions of membership and renewal thereof under Rule 11 of the Trade Organizations Rules, 2013.

As per Rule 15(2) of the Trade Organizations Rules, 2013, every member eligible to vote shall deposit with the Secretary General, PPMA, the Specimen Signature Card along with a recent photograph indicating his/her status in the member firm, company or concern. The right to vote shall be exercised only by the Proprietor, Partner, Director of the member firm or company, or a person not below the rank of General Manager duly authorized by the Board of Directors of a public limited company or a multinational corporation, as the case may be. At the time of polling, every voter shall produce the original PPMA Membership Card or any other valid identification document permissible under the Trade Organizations Rules, 2013, for verification of identity.

As per Rule 15(3) of the Trade Organizations Rules, 2013, the Proprietor, Partner, Director or duly authorized General Manager of the member firm or company shall be entitled to cast vote at the time of election only if his/her name has already been registered with the Secretary General, PPMA, and appears on the Final List of Voters.

Only those members whose membership and renewal are in full compliance with Rule 11 of the Trade Organizations Rules, 2013 shall be included in the Final List of Voters and be entitled to cast their vote.

In accordance with Article 31(c) of the Memorandum & Articles of Association of PPMA, Corporate Members shall cast their votes for the Corporate Members' seats, whereas Associate Members shall cast their votes for the Associate Members' seats only.

NOMINATIONS

1. Every member having no outstanding dues with the Association shall be entitled to file nomination for election to the Executive Committee only against the category of membership (Corporate or Associate) to which the member belongs, in accordance with the Memorandum & Articles of Association of the Pakistan Plastic Manufacturers Association (PPMA).
2. Nomination Papers shall be enclosed in a plain sealed envelope.
3. Nomination Papers shall be available at the PPMA Secretariat during office hours on the dates specified in the Election Schedule, duly signed and stamped by the Secretary General, PPMA.

Within four (4) days of the display of the Final List of Voters, every person eligible to contest the election for the vacant seat(s) of the Executive Committee shall send his/her nomination, duly proposed and seconded by a duly registered voter and signed by the candidate, to the Secretary General, PPMA on the prescribed form in accordance with the Trade Organizations Rules, 2013 and the Memorandum & Articles of Association of the Pakistan Plastic Manufacturers Association (PPMA).
